RENTAL AGREEMENT

AGREEMENT #CHSR0607

The undersigned hereby absolves and releases Tims Ford Sea-Doo & Boat Rentals L.L.C. its employees, officers, directors or other agents, from any and all claims and actions for damages in the event of any accident, mishap, injury, or damage, to the undersigned or any of their children or guests, while the undersigned, their children or guests are engaged in the rental use of equipment from Tims Ford Sea-Doo & Boat Rentals L.L.C.; and the undersigned hereby agrees to indemnify and save harmless, including all costs, and a reasonable attorney fee, the said Tims Ford Sea-Doo & Boat Rentals L.L.C., its employees, claims or actions offices, directors or other agents, from any and all damages from any and all arising out of the said use of their rental equipment, and the undersigned further agrees that they will take good and proper care of the rental equipment used by them and that in the event of damage thereto by the undersigned, their children, or guest, due to negligence or wear and tear beyond normal use that they will indemnify and save harmless the above named owner, Tims Ford Sea-Doo & Boat Rentals L.L.C., for the reasonable cost of repairs or replacement of same including all costs, and a reasonable attorney fee. Repairs must be performed by a business authorized by Tims Ford Sea-Doo & Boat Rentals L.L.C. and or vessel owner.

I, the undersigned, take full responsibility of any and all charges or penalties due to arrest or conviction of the equipment, due to illegal substances found on the undersigned, children, or guest of the undersigned, during operation of the equipment. **No alcoholic beverages shall be consumed by operator or passenger while using said rental equipment nor has it been consumed within six (6) hours prior to renting said equipment.**

I understand that Personal Watercraft and Power Boats are recreational vehicles which must be used with caution and care. Operators are warned to pay strict attention to instructions provided to them by the renter and to operate this Watercraft in a safe manner. Passengers, if any, are advised to avoid distracting or diverting the attention of the operator while the vehicle is in motion. Furthermore, it is recognized by both parties that in operating or riding any Jet Ski type recreational vehicle that they are assuming a certain degree of risk which may result in injury or death to the operator or passenger. PWC and Boats must stay in designated ride area.

Any operator must be Eighteen (18) years old to operate. I, the undersigned, acknowledge the fact that I must operate all rental equipment in compliance with all local, state, and federal laws. I, the undersigned, take full responsibility for returning all rental equipment on time and **agree that \$3.00 per minute will be deducted from the Security Deposit for any excess time.** I, the undersigned, will keep at least Two hundred (200) feet from all other Watercraft when under operation.

All rental equipment must be returned no later than four p.m. (4:00pm). I understand that I will not hold Tims Ford Sea-Doo & Boat Rentals L.L.C. liable for any injury resulting from a pre-existing medical condition that may occur during the use of this equipment. **Caution: This equipment can give a rough ride. Persons with back problems, seizure disorders, or any medical condition relating to same are encouraged not to rent. I acknowledge that I am not using any medications at this time - either prescription or nonprescription. I further acknowledge that I have been given full and proper instructions in operating the said equipment in a safe manner.**

****** All rental operators born after Jan. 1, 1989 must have in their possession a TWRA-issued card showing proof of successful completion of the TN. Boating Safety exam.**
